MANAGEMENT POLICY

1. Introduction

It is important to Scandinavian Energy Contractor A/S (SEC) that we ensure proper handling of your personal data. We aim to process your personal data in a transparent and secure method. This policy describes how we handle your personal data.

2. Personal data

Personal data is any information that relates to an identified or identifiable living individual. The purpose of this policy is to describe how SEC collects and processes data when you visit our website.

The policy applies to <u>www.secontractor.dk</u> and any other domains redirected to this domain. The policy does not apply to any other SEC-controlled systems collecting data. Privacy policies for other systems are available in the system in question.

3. Data controller

SEC is the legal entity and, as such, the data controller in accordance with the Danish Data Protection Act. We process personal data in accordance with the Danish Data Protection Act and the General Data Protection Regulation (EU 2016/679).

SEC collects cookie data. Some cookies are necessary for the website to work. Others are used for statistics and marketing purposes.

5. Cookies

A cookie is a small file which asks permission to be placed on your computer's hard drive. Once you agree, the file is added, and the cookie helps analyse web traffic or lets you know when you visit a particular site. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences.

We use traffic log cookies to identify which pages are being used. This helps us analyse data about webpage traffic and improve our website in order to tailor it to customer needs.
